## **APPROVAL OF MINUTES**

- Joyce: motion to approve November and December minutes
- Dan: second
- November and December Finance Committee minutes were approved

## FINANCIAL REPORT

- Presented by Danielle
  - Statement of Activity
    - Q1 2023 Contributions
      - Budgeted contribution number \$193,500?
      - Actual \$207,000 in current report
        - Now \$211,000
    - Budgeted Cuba revenues in January are not expected without a Development Director
    - KBOO sold the donated Marsh property
      - No more rent income
    - Q1 Total Revenues
      - Budget \$285,000
      - Actual \$299,999+
    - Q1 Total Expenses
      - Budget \$236,000
      - Actual \$196,000
        - Savings in open positions
          - Station manager
          - Development Director
          - Web/tech
          - Social media/fundraising assistant
        - Some planned projects haven't taken place yet
          - FCC project with Programming

- Balance Sheet
  - \$1,000,000+ in bank accounts
    - Need to update receivables
    - Need to update all signers
    - \$250,000 per EIN is protected
    - Bank deposits have up to \$250,000 in FDIC protection per depositor (or EIN) per bank or credit union
- Operating reserves
  - Increase to \$270,000 approved by the board in December
    - Need to make the bank account transfer
- Endowment
  - OCF updates monthly
  - Question as to how often KBOO's OCF account balance is updated on KBOO's balance sheet
    - No recommendation
    - Distributions made 2 times per year
      - reconcile/update then?
- ADP sent missed opportunity cost re: 401K
  - Danielle should have absolute value by board meeting on Monday, 1/23
- \$86,770 in unbudgeted expenses have been realized or are expected in the coming months
  - For example, UPS and electrical equipment
    - Insurance claim in progress
- \$34,685 in budgeted expenses are not expected to be realized
- \$34,000 in budgeted revenue is not expected to be realized
  - For example, whether we send KatMeow to Cuba
    - Emma, we should send KatMeow regardless
    - Danielle, 4 people need to sign up in order for the trip to happen

## STAFFING UPDATE

- Presented by Emma
  - Web/Tech job description ready to go
  - Development Director job description to be posted in the next week
  - Waiting on Social Media/Fundraising Assistant
  - Station Manager
    - 2 board meetings for open hearings
      - Hiring process starts 3/1/2023

## STORING KBOO'S MONEY

- Presented by Joyce
  - 1 million in cash yielded \$174 in interest last year
  - Options for higher yield accounts
    - Live Oaks Bank
      - No restrictions in savings account
      - 3.5% interest on \$250,000
      - 6 month CD at 4.35% interest, 1 year 4.6% but we don't meet minimum balance
    - FIrst INternet
      - .9% interest
      - 4.39% interest
      - 6 month CCD but need \$5 million
    - Sunflower Savings
      - 3.5%
      - 4% CD for 13 months
        - Pay less for longer terms
  - These are all online banks
  - Dan:
    - Balance the interest rate with the liquidity of the accounts
    - Consider keeping local, brick and mortar presence institution
    - Ensure FDIC protection on KBOO deposits at any bank or credit union that we choose to work with
  - Emma
    - Moving \$1 million may be too much
      - Maybe \$800,000
  - Danielle
    - Operating reserves are a good account for higher yield opportunity
  - Joyce
    - Reminder that these savings accounts are liquid, without restrictions
  - Danielle
    - If we reduce OnPoint to \$250,000 so it is fully insured
      - Need to remember the transmitter costs as we think about keeping liquid and covered for expenses

- Emma
  - Do we need a policy?
- Joyce
  - Insignificant interest is money lost
    - Requires god planning
  - Will call banks
- Joyce and Danielle make a proposal to the Finance Committee

#### 401K

- Danielle
  - ADP meeting to show opportunity lost
    - Danielle will invite Dan
- Dan

- Does this capture employees who weren't enrolled when the distributions were made?
- Danielle
  - If KBOO can't make the contribution for the employees would KBOO pay them directly?
  - There may be other opportunities to make employees whole outside the 401K.
- Emma
  - The 401K contribution could be perceived as a bonus
- Danielle
  - How do make employees whole who weren't enrolled, or were terminated, for their contributions.
- Dan
  - If an employee works for 4 months and then leaves, do they receive a bonus?
    - See language in the retirement plan portion in the CBA
- Emma
  - Will invite Dan to the next Management Bargaining meeting to discuss

## **FINANCIAL POLICIES**

- Ready for Governance and Policy Committee then on to the board
  - Spending authority outside the budget
    - Purchasing policy
  - Check signing limits
- Credit card policy to follow next month

## END-OF-YEAR FUNDRAISING CAMPAIGN

- \$18,000 over goal for December
- Still collecting January contributions
- \$1000 purchase for "double the donation" software
  - Searches for company matching gifts
  - Software is on track to pay for itself
